  - 6. County account /parcel #
  - 7. Copy of prior year COD
- 6. Please submit a separate list of the current year certificates of delinquency-for which no prior year claim exists-you would like to purchase at the tax sale. For each certificate of delinquency, the following information needs to be provided:
